How Should We Use Limited Resources to Support Our Capital Priorities with Limited Resources

Capital Investments – How Do We Choose?

- The most recent District assessment estimates \$500 million in capital improvement needs. This will likely increase to \$1.3B in five years.
- District currently does not generate revenue specifically for capital investment. We must rely on current revenue and/or fund balance.
- The District must prioritize investments with limited resources through the following analysis:
 - Immediate facility needs that interrupt the day to day operation of the school or place students and faculty in danger.
 - Schools with strong enrollment, higher utilization, lower FCI, and multiple needs.
- This overall analysis will ensure that our limited capital investments will yield long-term benefits.
- Utilize fund balance for one-time costs, not reoccurring personnel costs (\$85M now, no less than \$70-75M EOY (likely higher), preserve and protect \$35M reserve)

Recommendation Rubric

- The recommendations for the schools selected are derived from the following measures:
- 1.The percentage (%) of students enrolled in comparison to the capacity of the building (utilization rate). Those schools that have 50% or higher enrollment to capacity building's capacity rate meet the threshold.
- 2.Using the DPSCD's *Facility Assessment & School Facility Planning Report, the Facilities Condition Index (**FCI**) was the second measure. A score of 20 (the median) or less was selected as the threshold.
- 3.The final data reviewed was that the selected schools are in need of **multiple repairs**. This component was the 3rdmeasure to determine the list the schools that met or did not meet the threshold.

Recommendation Rubric Con't.

- *The schools selected represent a balanced list of needs.
- The schools that **meet** the threshold are those that have met all three measures (≥50% utilization, ≤20 FCI, ≥ multiple needs)
- The schools that **do NOT meet** the Threshold (outliers) may meet one (1) to two (2) of the components and have immediate, urgent needs for repairs.

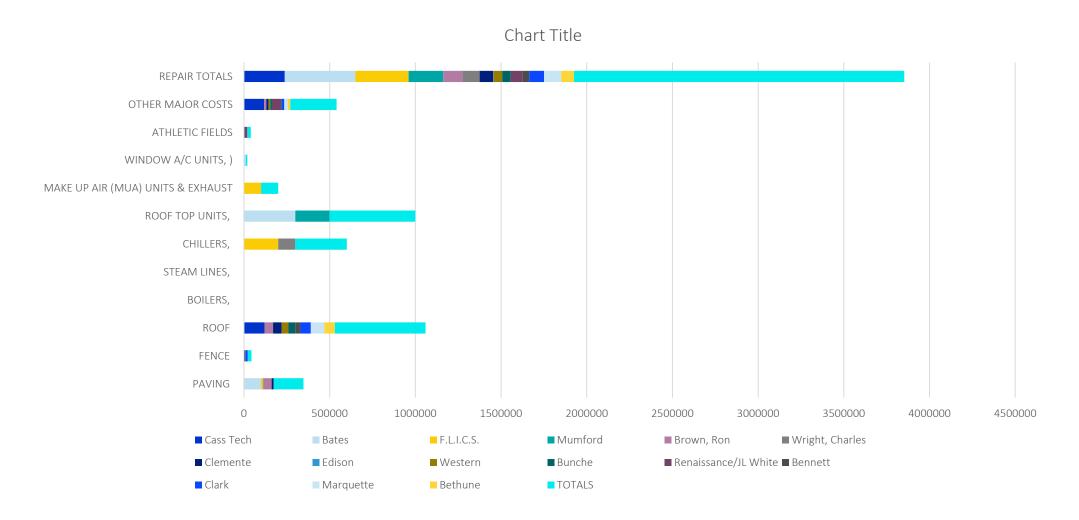

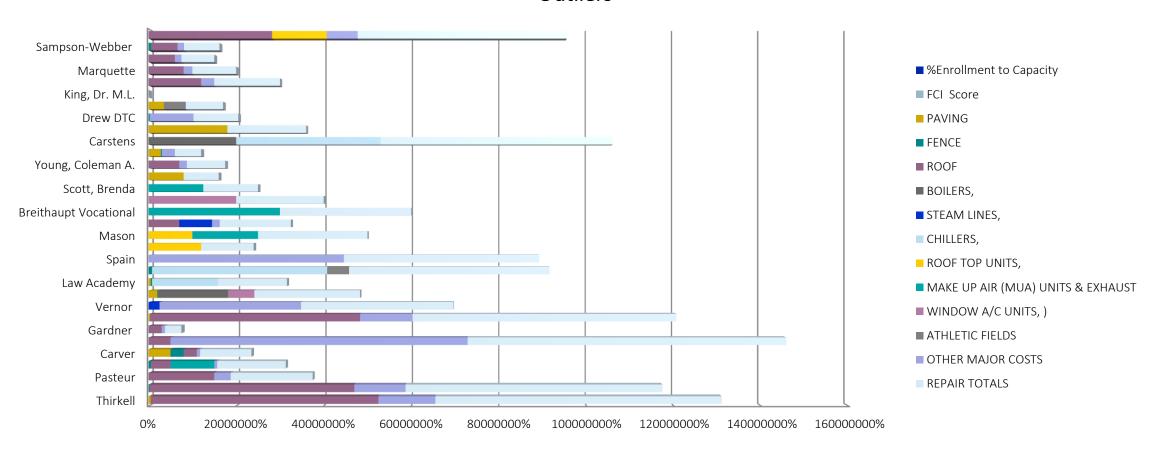

DPSCD FY 19 Proposed Capital Fund Budget Amendment through year ending June 30, 2019

- ✓ The Capital Projects Fund includes \$5.4 M of projects previously approved, this includes
 - ✓ \$2.8 M related to the Water Hydration Stations which are still in progress.
 - ✓ \$2.6 M for other projects including \$700K for Cass Tech Boiler and 350K for Roof repair at Central High School
- ✓ The District will transfer \$11.1 M from unrestricted general fund surplus and \$6.5 M from state transition funds.
- ✓ The District will operate schools in four current District facilities for the FY 20 school year.
 - ✓ Academy of America's High School will move from its current location at St. Anne's (lease) to Logan.
 - ✓ The District will open three new schools for the FY 20 school year on the site of Barton, Edmonson, and Hamilton.
- ✓ In order to address critical conditions of facilities the District will transfer \$9.7 M to address facility conditions at 42 District facilities.
- ✓ A contingency of \$3.5M (25%) is also being transferred to cover any unanticipated expenses.
- ✓ EOY projected fund balance will be no less than \$70-75M (like NETROIT PUBLIC SCHOOLS higher), not Including set-aside reserve of \$35M.
